Revise subsection 3 of section 2.2 of the KBC Bylaws to the following:

Entitled to limited access, pursuant to the conditions stipulated in the membership application. Junior members, excepting specified coaching times, may play only when an adult member, who has agreed to supervise the junior member, is present. A Junior Membership confers no voting rights.”
